



Terms & Conditions

Admission Ticket

1. Each ticket is valid throughout the designated date of purchase. Admission will be closed 30 minutes before the closing time of each day.
2. Each ticket admits one entry for one person aged three years or above only.
3. Seniors aged 65 or above, children aged 3 to 12, full-time students and people with disabilities are entitled to a 50% discount. Concessionary ticket holders are required to present identification documents upon admission.
4. Under the laws of Hong Kong, intoxicating liquor must not be sold or supplied to a minor under 18 years old in the course of business.
5. Wine and food tasting are subject to related terms and conditions of the Tasting Pass and Token.
6. Each ticket will only be accepted once. Once used, the QR code will be deactivated in the system and cannot be reused. Additional or duplicate copies will not be accepted.
7. Tickets sold are not refundable and non-exchangeable.
8. No replacement will be offered for any lost, defaced or damaged admission ticket.
9. The Hong Kong Tourism Board (HKTB) reserves the right to cancel the festival in case of inclement weather or other unforeseen reasons or circumstances. Appropriate announcements will be made on the day of the festival.

Tasting Pass

1. The Tasting Pass is valid throughout the festival period from 23 to 27 October 2024. Pass redemption and admission will be closed 30 minutes before the closing time of each day.
2. Participants must be aged 18 years or above and bear an official stamp on the hand or any visible part of the body to be eligible for wine tasting and must produce proof of age, e.g. identity card, passport or other travel documents, for inspection upon the request of festival staff.
3. The eight-token tasting pass (valued at HK\$200); the 14-token tasting pass (valued at HK\$400) comes with one wine glass.
4. Tokens will be stored on a smart card. The tokens can be used at any booths at the festival for wine and food tasting. Tokens are required for each tasting according to the display at respective booths, as advised by the exhibitors.. A wine tasting portion is approximately 40ml for wine; 10ml – 15ml for whisky; 80ml to 120ml for craft beer; 30ml for sake; 60ml as least for gin, cocktail & other spirits.
5. The exhibitor will provide designated wines or food for tasting and is responsible for serving the portion. Each Token can only be used once and will be deducted from the smart card by the exhibitor after use for accounting purposes.
6. Tasting Pass and Token are non-refundable and non-exchangeable.
7. Tasting Pass and Token will be invalid if defaced or damaged. Lost, defaced or damaged Tasting Pass and Tokens will not be replaced.
8. No exchanges or replacements will be offered for the wine glass once it has been collected.
9. The Organiser reserves the right to cancel the festival in case of inclement weather or other unforeseen reasons or circumstances. Appropriate announcements will be made on the day of the festival.

Token

Tokens are required for each tasting according to the display at respective booths, as advised by the exhibitors.. A wine tasting portion is approximately 40ml for wine; 10ml – 15ml for whisky; 80ml to 120ml for craft beer; 30ml for sake; 60ml as least for gin, cocktail & other spirits.

4. Participants aged 13-17 must have a [consent](#) form signed by a parent or guardian and present it at the Tasting Theatre entrance.
5. Children aged 3-12 must be accompanied by a parent or guardian. Children aged under 3 will not be entertained.
6. Wine and food tasting are subject to related terms and conditions of Tasting Pass and Token.
7. Each ticket will only be accepted once. Once used, the QR code will be deactivated from the system and cannot be reused. Additional or duplicate copies will not be accepted.
8. Tickets sold are not refundable.
9. No replacement will be offered for any lost, defaced or damaged Tasting Theatre Programme ticket.
