

Terms & Conditions

The following terms and conditions apply to all participants attending the Hong Kong Wine & Dine Festival (the "Event") organised by the Hong Kong Tourism Board ("HKTB" or the "Organiser"), to be held from 23 to 26 October 2025 at the Central Harbourfront Event Space By attending the Event, all participants agree to abide by the following terms and conditions.

Admission Ticket

- 1. Each ticket is valid during the Event period from 23 to 26 October 2025. Admission will close 30 minutes before the closing time of each day.
- 2. Each ticket admits one entry for one person aged 3 or above only.
- 3. Seniors aged 65 or above, children aged 3 to 12, full-time students and people with disabilities are entitled to a 50% discount. Concessionary ticket holders are required to present identification documents upon admission.
- 4. Under the laws of Hong Kong, intoxicating liquor must not be sold or supplied to a minor under 18 years old in the course of business.
- 5. Wine and food tastings are subject to related terms and conditions of the applicable Tasting Pass and token to be used at the Event ("Token(s)").
- 6. Each ticket will only be accepted once. Once used, the QR code will be deactivated in the system and cannot be reused. Additional or duplicate copies will not be accepted.
- 7. Tickets sold are not refundable and non-exchangeable, cannot be re-sold and will be void if altered.
- 8. No replacement will be offered for any lost, stolen, defaced or damaged admission ticket.
- 9. HKTB reserves the right to cancel the Event in case of inclement weather or other unforeseen reasons or circumstances. Appropriate announcements will be made on the day of the Event.
- 10. Admission tickets, whether in a physical or digital format, will be collected and/or scanned by staff at the event entrance.



- 11. The Organiser and its subcontractors have the right to make video recordings or take photos for the Event. Such footage or photographs may be used in promotional or publicity events or for other purposes deemed fit by the Organiser. By attending the Event, participants acknowledge that they may be captured in the footage or photographs during the Event and give consent to the Organiser for the use of such footage and photographs throughout the world in perpetuity and in any media.
- 12. House Rules apply. In the event of disputes, HKTB reserves the right of final decision on all matters concerned.



Tasting Pass

- 1. The Tasting Pass is valid throughout the Event period from 23 to 26 October 2025. Pass redemption and admission will close 30 minutes before the closing time of each day.
- 2. The Tasting Pass comes with 8 Tokens and one standard wine glass.
- 3. Participants must be aged 18 years or above and bear an official stamp on the hand or any visible part of the body to be eligible for wine tasting and must produce proof of age, e.g. identity card, passport or other travel documents, for inspection upon the request of Event staff.
- 4. Tokens will be stored on a smart card. The Tokens can be used at any booth at the Event for wine and food tasting. Tokens are required for each tasting according to the display at respective booths, as advised by the exhibitors. A wine tasting portion is approximately 40ml for wine; 10ml to 15ml for whisky; 80ml to 120ml for craft beer; 30ml for sake; and at least 60ml for gin, cocktails & other spirits.
- 5. The exhibitors will provide designated wines or food for tasting and are responsible for serving the portion. Each Token can only be used once and will be deducted from the smart card by the exhibitors after use for accounting purposes.
- 6. The Tasting Pass and Tokens sold are not refundable and non-exchangeable, cannot be re-sold and will be void if altered.
- 7. The Tasting Pass and Tokens will be invalid if defaced or damaged. Any lost, stolen, defaced or damaged Tasting Pass and Token will not be replaced.
- 8. No exchanges or replacements will be offered for the wine glass once it has been collected.
- 9. The Organiser reserves the right to cancel the Event in case of inclement weather or other unforeseen reasons or circumstances. Appropriate announcements will be made on the day of the Event.
- 10. HKTB is not a supplier of the products and services provided by the exhibitors and shall not be responsible for any liabilities in relation thereto. In the event of disputes between the participants and exhibitors relating to the aforementioned products and services, the exhibitors reserve the right of final decision on all matters concerned.
- 11. House Rules apply. In the event of disputes, HKTB reserves the right of final decision on all matters concerned.



Token

- 1. The Token is valid throughout the festival period from 23 to 265 October 2024.
- 2. Participants must be aged 18 years or above and bear an official stamp on the hand or any visible part of the body to be eligible for wine tasting and must produce proof of age, e.g. identity card, passport or other travel documents, for inspection upon the request of festival staff.
- 3. The Token will be stored on a smart card. The tokens can be used at any booths at the festival for wine and food tasting. Tokens are required for each tasting according to the display at respective booths, as advised by the exhibitors. A wine tasting portion is approximately 40ml for wine; 10ml to 15ml for whisky, gin & other spirits; 80ml to 120ml for craft beer; 30ml for sake; and at least 60ml for cocktails.
- 4. The participating exhibitor will provide designated wines or food for tasting and is responsible for serving the portion. Each Token can only be used once and will be deducted from the smart card by the exhibitor after use for accounting purposes.
- 5. Tokens are non-transferable, non-refundable and non-exchangeable.
- 6. Tokens will be invalid if defaced or damaged. Lost, defaced or damaged Tokens will not be replaced.
- 7. The Organiser reserves the right to cancel the festival in case of inclement weather or other unforeseen reasons or circumstances. Appropriate announcements will be made on the day of the festival.
- 8. The Hong Kong Tourism Board (HKTB) is not a supplier of the products and services provided by the exhibitors and shall not be responsible for any liabilities in relation thereto.
- 9. HKTB and participating exhibitors reserve the right of final decision in case of any disputes



Grand Wine Tasting Pass

- 1. The Grand Wine Tasting Pass is valid throughout the Event period from 23 to 26 October 2025. Pass redemption and admission will be close 30 minutes before the closing time of each day.
- 2. The Grand Wine Tasting Pass comes with 16 Tokens, one Grand wine glass and a snack coupon.
- 3. Any person under the age of 18 will not be admitted to the Grand Wine Pavilion. Participants must be aged 18 years or above and bear an official stamp on the hand or any visible part of the body to be eligible for wine tasting and must produce proof of age, e.g. identity card, passport or other travel documents, upon the request of Event staff.
- 4. The Pass allows unlimited entry to the Grand Wine Pavilion on the collection day. Re-entry is subject to crowd control measures, including queuing and venue capacity limits once the maximum number of guests is reached.
- 5. No food and/or drink is allowed other than those served at the Grand Wine Pavilion.
- 6. Tokens will be stored on a smart card. The Tokens can be used at any booth at the Event for wine and food tasting. Tokens are required for each tasting according to the display at respective booths, as advised by the exhibitors. A wine tasting portion is approximately 40ml for wine; 10ml to 15ml for whisky; 80ml to 120ml for craft beer; 30ml for sake; and at least 60ml for gin, cocktails & other spirits.
- 7. The exhibitors will provide designated wines or food for tasting and are responsible for serving the portion. Each Token can only be used once and will be deducted from the smart card by the exhibitors after use for accounting purposes.
- 8. The Grand Wine Tasting Pass and Tokens sold are not refundable and non-exchangeable, cannot be re-sold and will be void if altered.
- 9. The Grand Wine Tasting Pass and Tokens will be invalid if defaced or damaged. Any lost, stolen, defaced or damaged Tasting Pass and Tokens will not be replaced.
- 10. No exchanges or replacements will be offered for the wine glass and any complimentary snacks once it has been collected.
- 11. The Organiser reserves the right to cancel the Event in case of inclement weather or other unforeseen reasons or circumstances. Appropriate announcements will be made on the day of the Event.

Token

- 3. The Tokens will be stored on a smart card. The Tokens can be used at any booth at the Event for wine and food tasting. Tokens are required for each tasting according to the display at respective booths, as advised by the exhibitors. A wine tasting portion is approximately 40ml for wine; 10ml 15ml for whisky; 80ml to 120ml for craft beer; 30ml for sake; and at least 60ml for gin, cocktails & other spirits.
- 4. The participating exhibitors will provide designated wines or food for tasting and are responsible for serving the portion. Each Token can only be used once and will be deducted from the smart card by the exhibitors after use for accounting purposes.
- 5. Tokens are non-refundable and non-exchangeable, cannot be re-sold and will be void if altered.
- 6. Tokens will be invalid if defaced or damaged. Lost, stolen defaced or damaged Tokens will not be replaced.

Grand Wine Pavilion

- 1. Grand Wine Pavilion Access ("Access") will be available for purchase at the door of the Grand Wine Pavilion for Tasting Pass holders only. Access sales will stop 30 minutes before the closing time of each day.
- 2. No concessionary ticket will be available for all Access. Access allows unlimited entry to the Grand Wine Pavilion on the collection day. Re-entry is subject to crowd control measures, including queuing and venue capacity limits once the maximum number of guests is reached.
- 3. Any person who is under the age of 18 will not be admitted to the Grand Wine Pavilion. Participants must be aged 18 years or above to be eligible for wine tasting and must produce proof of age, e.g. identity card, passport or other travel documents, upon the request of Event staff.
- 4. This Access is non-transferable, non-refundable and non-exchangeable, cannot be re-sold and will be void if altered.
- 5. This Access will not be replaced in case of loss, stolen, defacement or damage. Lost, stolen, defaced or damaged Access will not be replaced.
- 6. The exhibitors will provide designated wines or food for tasting and are responsible for serving the portion. Each Token can only be used once and will be deducted from the smart card by the exhibitors after use for accounting purposes.
- 7. No food and/or drink is allowed other than those served at the Grand Wine Pavilion.
- 8. The Organiser reserves the right to cancel the Event in case of inclement weather or other unforeseen reasons or circumstances. Appropriate announcements will be made on the day of the Event.
- 9. HKTB is not a supplier of the products and services provided by the exhibitors and shall not be responsible for any liabilities in relation thereto. Tasting Room

- 1. The Tasting Room ticket includes admission to the Event.
- 2. This ticket is only valid for the selected time slot, and each ticket admits one entry for one person only (unless otherwise specified). Please arrive at the Tasting Room 10 minutes before the programme starts.
- 3. Any person who is under the age of 18 will not be admitted to the Tasting Room Dinner session. Participants must be aged 18 years or above and bear an official stamp on the hand or any visible part of the body to be eligible for wine tasting and must produce proof of age, e.g. identity card, passport or other travel documents, for inspection upon the request of Event staff.
- 4. No concessionary ticket will be available for Tasting Room tickets. Children under the age of 3 dine free of charge with a paying adult but must be accompanied by an adult and will not occupy a separate seat. Participants aged 3 to 17 are required to pay the full ticket price. Children aged 3-12 must be accompanied by a parent or guardian.
- 5. Each ticket will only be accepted once. Once used, the QR code will be deactivated from the system and cannot be reused. Additional or duplicate copies will not be accepted.
- 6. Tickets are non-transferable, non-refundable and non-exchangeable, cannot be re-sold and will be void if altered.
- 7. No food and/or drink is allowed other than those served at the Tasting Room.
- 8. No replacement will be offered for any lost, stolen, defaced or damaged Tasting Room ticket.
- 9. This ticket, whether in a physical or digital format, will be collected and/or scanned by staff at the Tasting Room entrance.
- 10. HKTB reserves the right to cancel the Event and/or any programme to take place at the Tasting Room in case of inclement weather or other unforeseen reasons or circumstances. Appropriate announcements will be made on the day of the Event.
- 11. HKTB is not a supplier of the products and services provided by the catering service provider and shall not be responsible for any liabilities in relation thereto. In the event of disputes between the participants and the catering service provider relating to the aforementioned products and services, the catering service provider reserves the right of final decision on all matters concerned
